PRESENT: Mayor Laureen Tackman, Trustees John Scatena. Trevor Maughan, Eric Cartier and Robin Wilson, Debra and Mark Everson, John Hinds. Legislator Reehil arrived at 6;30pm.

PULIC HEARING CALLED TO ORDER by Mayor Tackman at 6:00 pm with Pledge of Allegiance.

The Mayor presented the 2024-25 Village Budget. Total appropriations of \$1,120,968.00. Debra Everson guestioned if there were any monies set aside within the budget for the rebuilding of Bridge Street. The Mayor and the Clerk responded no, as the intention is to utilize CHIPS funds for the Village portion of the 25% match of the \$1,000,000 grant received as well as the \$150,000 emergency USDA funding that is going toward the repair. Since the repair will not begin until 2026 money to be allocated in next year's budget. Mayor Tackman gave the highlights of the budget including Increase for employees per union contract, at \$1.00 per hour, an increase for Code Enforcement of \$500 annually and \$500 annually for the water/sewer billing clerk. Health Insurance increase of 2.5% annually, (far less than the 12% increase with previous coverage) but our health care costs overall have increased. Mayor Tackman reported that we need to pay employees in order to keep them and these are necessary cost increases.

A - General Fund is utilizing \$7,093 from fund balance. A1001 – Property Taxes – Increased with the tax cap to \$172,127, which is an increase of \$3,426.00, A5142.4 - Salt - This is much higher as we didn't order salt last year, so we need to increase or order from 120 ton to 189 ton and we have to give some to Town of Vienna as we borrowed from them due to the harsh winter. FX – Water – Balanced, and G– Sewer – utilizing \$9,151 from fund balance. She also reported that all the buildings and utilities have generators now. She would like to look into getting a grant to revitalize Memorial Park on Rt. 49. There is some deterioration of the concert around the flag pole that needs to be repaired. With no further questions, at 6:19pm, Mayor Tackman made a motion to close the public hearing, second by Trustee Wilson, all in favor.

**REGULAR MEETING 6:30PM** by Mayor Tackman at 6:30 pm with Pledge of Allegiance.

Travis Bliss, from Bliss Environmental delivered the only garage bid for opening. The bid stated the cart rental would remain the same at \$1.25 per month and the overall annual cost for 2025-2027 would be \$69,600. Note that if the tipping fees in Oswego County go up during the contract period, we would increase the monthly price accordingly to cover the disposal costs increase. It would be a mutual agreement between Bliss and the Village. Mayor Tackman made a motion to accept the bid from Bliss for \$69,600 annually, second by Trustee Wilson, all in favor.

PUBLIC COMMENT: Mark Everson spoke up regarding the proposed Dollar General at the site of TJ's restaurant. He stated he and his wife own approximately 20' between TJ's restaurant and the trail. He presented pictures of an old tractor trailer that was brought in by Tom Mirizio years ago and would like to be sure this is not allowed to be left there and would like it addressed. Mayor Tackman will discuss with the Code Officer. She stated they should have brought this up sooner and we could have addressed it sooner. He also brought up the fact there is very poor drainage in front of the current restaurant and if they intent to pave when the store is there is will create more issues. Trustee Scatena stated that the engineers for the project will address this issue. Again, nothing has been brought before the planning/zoning board yet, this is all very preliminary. Mr. Reehil inquired about when the Bridge Street project is completed will there be able to be speed bumps installed, and Mayor Tackman stated absolutely. She wants to see them to curtail the speeding as well. Debra Everson stated so many large trucks go through that portion and they are overweight limits and cause so much damage to the roads. She would like to see a tonnage sign put up as there was one there years ago, but has been down for a long time.

**LEGISLATOR'S REPORT:** Roy only had one item to share that there is only 1 property from the village in the auction. He will get us the information on it as soon as he can.

BUDGET ADOPTION: Mayor Tackman made a motion to adopt the 2025-26 Village Budget with total appropriations of \$1,120.968, second by Trustee Scatena, all in favor.

PAY BILLS: Mayor Tackman made a motion to pay April abstract #11, vouchers #495-542 for \$89779.71, the Treasurer's Report, and amendments to the Union Contract, second by Trustee Maughan, all in favor.

VILLAGE ELECTION RESOLUTION: Mayor Tackman made the following resolution, second by Trustee Scatena, all in favor.

Applications are now open through the on-line Consolidated Funding Application with a deadline of May 2 at 4:00 p.m. For the 2025 grant cycle, successful MPR project applications will be funded with up to \$10 million in Bond Act funds from the Open Space Land Conservation and Recreation category. An additional grant cycle will occur in the future, bringing the program total to \$20 million through two rounds of applications. The MPR grant opportunity can fund up to 90% of the total eligible project costs, with a matching share requirement of 10%. The maximum grant award is \$1,000,000.
